## Westside Reservoir Project:








This Project is 95% complete and will be completed by June 2022. The reservoir is on, and now feeding the Mid-Valley of our District.

Crystal Springs Water District welcomes our new customers of the former Odell Water Company. The consolidation of Odell Water Company was completed December 31, 2021. We look forward to serving you. Future plans include rebuilding the Davis spring source. This will make this source protected from surface influence and protect it from contamination. When complete it will provide our District with emergency water source.
